Dukgeun Ahn is a Professor at the Graduate School of International Studies (GSIS) of Seoul National University. At Seoul National University he teaches and researches in the field of international trade policy. His expertise lies in WTO law and policy and trade negotiation. Ahn holds a JD from the University of Michigan Law School and is a member of the New York State Bar Association. He received his PhD in Economics from the University of Michigan and completed his BA in International Economics at Seoul National University. At Seoul National University, Ahn has served as Director of the Center for International Commerce and Finance, as an Associate and Adjunct Professor at the Law School and as an Adjunct Professor at the Technology & Economic Policy Program. He has been the recipient of several awards and has published widely on trade and financial institutions both in English and Korean.

Taeho Bark is a Professor of International Commerce at the Graduate School of International Studies (GSIS) of Seoul National University. At Seoul National University, he also served as Dean for International Affairs as well as Director of the Institute for International Studies. Until recently, Bark was the Chairman of the Korea International Trade Commission. Previously, Bark taught at Georgetown University, worked as a Senior Research Fellow of the Korea Development Institute (KDI) and served as the Vice President of the Korea Institute for International Economic Policy (KIEP). He also worked on international commerce issues as a Senior Economist in the Office of the President of the Republic of Korea. Between 2000 and 2002, Bark served as Chair of the Investment Expert Group (IEG) of Asia-Pacific Economic Cooperation (APEC). He also taught at the Jackson School of International Studies at University of Washington and at the Asia-Pacific Research Center (APARC) of Stanford University as a Visiting Professor. In addition, he was a Visiting Scholar at the IMF and has consulted for the World Bank. He has written a few books and many articles on international trade, foreign direct investment and the Korean economy. Professor Bark received his BA from Seoul National University and PhD in economics from the University of Wisconsin-Madison.

David Kleimann is a graduate of the World Trade Institute in Berne. After his academic training in trade law and economics in Switzerland, he has gained practical experience at the WTO Agriculture Division, the Directorate General for External Trade in the European Commission, and the Economic Policy Program of the German Marshall Fund of the United States (GMF). In September 2010, he joined the Law Department of the European University Institute (EUI) in Florence, where he conducts research on adjudication of agricultural trade disputes by the WTO Dispute Settlement Body.

Woo-Sik Moon is a Professor at the Graduate School of International Studies (GSIS) of Seoul National University. At Seoul National University he is a teacher and researcher in the field of International Finance and European Economy. Moon holds a PhD in Economics form the University of Paris (Pantheon-Sorbonne), where he also received a MA in Economics in the Department of Money, Finance and Banking at the University of Paris. He earned his BA in Economics from the Department of International Economics at Seoul National University. Prior to his current work as a Professor at GSIS, he was a Research Fellow at the Korean Development Institute. Moon is published widely in both English and Korean.

Yeongseop Rhee is a Professor of Economics at the Graduate School of International Studies (GSIS) of Seoul National University. At Seoul National University, he teaches and researches in the areas of International Finance, Regional Integration and North Korean Economy. Rhee received his PhD in Economics from the University of California (UC), Berkeley, where he had previously completed his MA in Statistics. He holds a second MA in Economics, which he received from Seoul National University (SNU), where he also earned his BA in Economics. Rhee has served as Professor in the Department of Economics as well as the Department of Foreign Trade at Sookmyung University. He was a Non-resident Fellow at the Brookings Institution and also a Visiting Fellow at Korean and international institutions, such as the University of Tokyo and the University of California (UC), Berkeley. Other noteworthy positions include his service as President of the EU Studies Association (EUSA) in Korea and his role as Executive Director of the Korean Economic Association (KEA). Since 2009 he has been part of the Executive Committee of the Korean Money and Finance Association (KMFA) and has been Chairman of the Panel for Analysis of the Korean Economy. He is the author and co-author of several books and articles on finance and economics in both English and Korean.
